	<p><u>LEGISLATIVE LEADERSHIP AWARD</u>: Awarded to members of the state and/ or federal legislature who consistently support law enforcement with their involvement in bills that positively affect law enforcement in California.</p>
	<p><u>CIVIC LEADERSHIP AWARD</u>: Awarded to city and county administrators who have consistently acted in the best interest of public safety and law enforcement.</p>
	<p><u>HUMANITARIAN OF THE YEAR</u>: Awarded to a noteworthy member of the community whose actions and/or contributions greatly benefited law enforcement.</p>
	<p><u>UNSUNG HEROES AWARD</u>: Awarded to law enforcement officers who have served heroically beyond the call of duty, yet have not been recognized by their agency or any other agency.</p>
	<p><u>GOLD BADGE OF COURAGE AWARD</u>: Awarded to law enforcement officers who while performing in the scope of duties suffered life-threatening injuries, yet recovered and returned to duty.</p>
	<p><u>TOP SUPERVISOR'S AWARD</u>: Awarded to law enforcement supervisors whose performance went beyond the call of duty to improve officer safety, interdepartmental relations, and/or the agency's public image.</p>
	<p><u>TOP MANAGEMENT AWARD</u>: Awarded to law enforcement managers whose performance went beyond the call of duty to improve officer safety, interdepartmental relations, and/or the agency's public image.</p>
	<p><u>LIFETIME ACHIEVEMENT AWARD</u>: Awarded to enforcement officers who improved the quality of life within their community through their dedication and involvement in the community.</p>
	<p><u>LABOR LIFETIME ACHIEVEMENT AWARD</u>: Awarded to law enforcement officers who have devoted an extraordinary amount of time improving the benefits, positive image and quality of life for their brothers and sisters in law enforcement through union and association involvement.</p>
	<p><u>EXEMPLARY PERFORMANCE AWARD</u>: Awarded to law enforcement officers whose extra effort above and beyond the call of duty resulted in saving lives, solving difficult case(s), or drastically impacting the reduction in crime rate in an area through consistent enforcement.</p>
